Award Nominees Receive Certificates of Acknowledgement

At the annual SIWIB meeting on June 21, 2007 at the Herrin Civic Center, Chairman Armstrong presented four certificates to the following worthy nominees.

The Ruth Snider Individual Achievement Award recognizes the accomplishments of WIA job seeking customers who have overcome significant obstacles in achieving their personal career goals. Two of our Maytag/Whirlpool dislocated workers were nominated for this prestigious award.

Amber Jarvis has overcome many obstacles that have threatened to interfere with her plans of completing a Bachelors Degree in Southern Illinois University Carbondale's Administration of Justice program. Even in the face of diversity, Amber's dedication was evidenced by perfect attendance in class and an excellent grade point average. She even found time to complete sixty hours of volunteer work at Man-Tra-Con assisting other former Maytag employees.

Sixty-one year old Jerry Mezo finally admitted that he was functionally illiterate after the announcement of the December 2006 plant closure. It was painfully clear that he would need to learn to read in order to obtain a GED to assist in job search. With the help of Man-Tra-Con, John A. Logan's

Adult Education Program, Herrin Public Library's Literacy Outreach, and volunteer tutors, Jerry is now reading books, menus, street signs, and directions. Jerry's accomplishments have been an inspiration and a source of pride for himself, his family, and his teachers.

The Innovative Solutions Award recognizes innovative workforce/economic development programs, projects, and/or initiatives that have resulted in the economic growth of a community or region. The Williamson County Regional Airport, and its Chicago air service, was nominated for this award. In February 2007, the airport started passenger air service to Chicago and now provides a quick and convenient alternative to area residents whether for leisure, tourism, or to explore business development. Successful implementation of this initiative resulted in multiple partnership formation within the community and region. State Senator Gary Forby, State Representative John Bradley, the Illinois Department of Transportation, the Division of Aeronautics, Decatur Airport, Quincy Airport, REDCO, local chambers, community leaders, and lastly MESA Airlines all came together to help capture the roundtrip air service from southern Illinois to Chicago. *(Continued on page 3)*

One-Stop Committee

The One-Stop Committee Meeting was held at the Marion Man-Tra-Con office on June 5, 2007. Traffic reports, customer satisfaction surveys, and utilization reports were distributed to the attendees. Cindy Webb, Scott Cohoon, and Pat Drake gave a brief overview of their respective One-Stop Center locations. The influx of migrant seasonal workers into the system is a direct result of crop destruction earlier in the spring.

A summary of events focusing on the dislocated Maytag and Technicolor Universal Media Services workers was provided. A successful Employment Opportunity Fair was held on May 15, 2007 with 445 job seekers in attendance. Job Clubs, College Prep Days, and informational healthcare workshops have served many of those faced with recent job loss. A picnic for former

TUMS workers and their families was held on Saturday, June 16, 2007 at the DuQuoin Fairgrounds Ash Grove Pavilion with more than 100 in attendance for hot dogs, fun, and games!

Julio Rodriguez with the Department of Commerce and Economic Opportunity joined the meeting via conference call to explain the One-Stop rebranding campaign. He recognizes the challenges of integrating the One-Stop logo with the Illinois workNet logo and with other partnering agencies. Copies of potential new logo designs were distributed; the committee will discuss specific revisions at a later date. The committee selected award nominees recognized at the Annual SIWIB meeting on June 21, 2007 that included Business Leadership, Innovative Solutions, and two Ruth Snider Individual Achievement categories. reported on construction and refurbishing efforts at many of the locations. The next meeting date has yet to be determined.

Youth Council

The Youth Council made a recommendation to the SIWIB and received approval to fund all proposals received in response to Requests for Proposal for education and employment services beginning July 1, 2007.

Contracts for employment services will be issued to MERS/Goodwill for \$71,782.11 and Hamilton Jefferson Counties' Regional Office of Education for \$40,000.00.

Education contracts will be given to Carbondale Community High School Rebound for \$65,677.50, Project ECHO for \$72,800.00, Hamilton Jefferson Counties' Regional Office of Education for \$36,132.00 and United Methodist Children's Home YouthBuild for \$26,182.92.

Since there were no employment proposals received for Franklin, Perry, and Williamson Counties, or education proposals for Perry County, youth from those counties will receive services or referral to services, case management and supportive services from Man-Tra-Con staff.

Contracts for Program Year 2007 will again be 70% cost reimbursement and 30% cost reimbursement/performance based on Common Measures for Performance guidelines. The Youth Council required contractors to meet Common Measures last year to familiarize and prepare them for WIA Reauthorization. The State recently received a waiver stating Common Measures for WIA youth would begin for Program Year 2008, meaning all youth exited from WIA after September 30, 2008 will be counted in the new measures. ■
