LWIA 25 and LWIA 26 Address Barriers for Region's Employers

In an unprecedented joint session, the **Executive Committees of the Southern Illinois** Workforce Investment Board (SIWIB) and the Southern 14 Workforce Investment Board came together on July 31, 2008, at the Illinois workNet Center in Harrisburg. This meeting provided a venue for the two boards to discuss the workforce issues previously identified by the Connect SI **Business Retention and Expansion Survey** sponsored by the SIWIB. The survey results are a compilation of responses from 1,998 businesses in the 20 southernmost counties. Assembling both boards personified the spirit of regionalism and collaboration to mutually address these issues.

The primary focus for the discussion was the work ethic of the region's workforce — identified as the top employee deficiency by employers. Questions about employee commuting patterns, growth/expansion pockets, and educating employers on the international trade process were topics

that can be expanded on in both LWIAs. Plans were proposed to disseminate the survey findings and to develop regional strategies to address the issues identified in the survey. The potential of a joint press release was also addressed by the group. Both boards look forward to continued opportunities to convene in a unified approach. Workforce Investment Board. Forty employees of the company were given Basic Quality instruction through John A. Logan College. Basic Quality is tailored around the Department of Defense Quality Management Program and is a core curriculum feature of the Certified Quality Improvement Associate's (CQIA) program developed by the American Society for Quality (ASQ).

The Incumbent Worker Training (IWT) program helps employers upgrade the skills of their workforce in order to become and remain competitive in both regional and global markets. Incumbent worker training is also designed to keep workers employed, prevent layoffs, enhance worker skills, increase wages earned by employees, and improve employee marketability. The IWT program is administered by Man-Tra-Con in partnership with One-Stop Business and Employment workNet Centers, the Department of

Commerce and Economic Opportunity and business and industry sectors. Funding for IWT comes from the Adult, Youth and Dislocated Worker programs under the Department of Labor's federally funded Workforce Investment Act. Companies receiving the training grants are required to provide a percentage of the matching funds.

The IWT program will benefit General Dynamics and the area economy in a variety of ways. Officials at General Dynamics stated that future hiring expectations potentially exist as a direct result of this training opportunity. The training is expected to stabilize the workforce within the department and lead to consistency in product quality. Improvements in product quality will lead to higher customer satisfaction. Customer satisfaction will lead to increased sales. Increased sales volume will produce more jobs. A win-win for everyone!
